## *Entrepreneurial Spirit Award*

- Nominee must have been in business for 3 or more years
- Nominee must be a Member of the Western DuPage Chamber of Commerce, continually for a minimum of 2 years and in good standing
- Nominee must be an independent business demonstrating business acumen, innovation in leadership, management and business practices
- Nominee should demonstrate financial stability, community involvement and social responsibility

## *Enterprise Spirit Award*

- Nominee must have been in business for 3 or more years
- Nominee must be a Member of the Western DuPage Chamber of Commerce, continually for a minimum of 2 years and in good standing
- Nominee must be active in the Chamber and other community organizations
- Nominee should demonstrate positive social and/or economic impact on the region
- Nominee must exemplify excellent corporate citizenship by giving back to our local community and has a corporate culture that enhances the lives of its employees

## *Service Spirit Award*

- Nominee must be a Western DuPage Chamber of Commerce member, in good standing
- Nominee is recognized as any individual, company or organization dedicated to improving lives within the region through their services
